SR-17 Professional Service Agreement with Teach For America (TFA) to provide 10-20 highly qualified teachers to Jefferson Parish Public School System for the 2015-2016 and 2016-2017 school years. (Deferred to 5/6/2015)

JPPSS anticipates filling more than 300 vacancies resulting from employment separations and retirements in the 2014-2015 school year. While working to retain our most highly effective teachers, we know we also need a diverse set of recruitment strategies to ensure we have a highly qualified teacher in every classroom. As part of the district's ongoing teacher recruitment efforts, Human Capital will utilize a comprehensive plan that involves multiple strategies. Recruitment efforts will be targeted within the Greater New Orleans Area and also some targeted nationwide efforts. These strategies include, but are not limited to, recruiting:

- -Experienced certified teachers from other parishes, private and parochial schools
- -Recent College and university graduates from across the state
- -Alternatively certified professionals from partner colleges and universities, as well as, organizations such as Teach for America (TFA) (10-20 teachers)
- -Targeted out of state candidates from English as a Second Language certification programs and the National Alliance of Black School Educators
- -In 2013-2014, half of the TFA teachers hired in JPPSS worked in critical shortage area classrooms and 20% were identified as bilingual. Teach For America will continue to recruit teachers who meet these high need areas for JPPSS classrooms.

The two year contract will cover the cost of recruitment, training and support of 10-20 teachers at an annual cost of \$3800 per teacher for up to two years. The maximum total cost of this contract, for each academic year, is \$133,000. Funding source will be the Title II Fund for the 2015-2016 and 2016-2017 school years.
